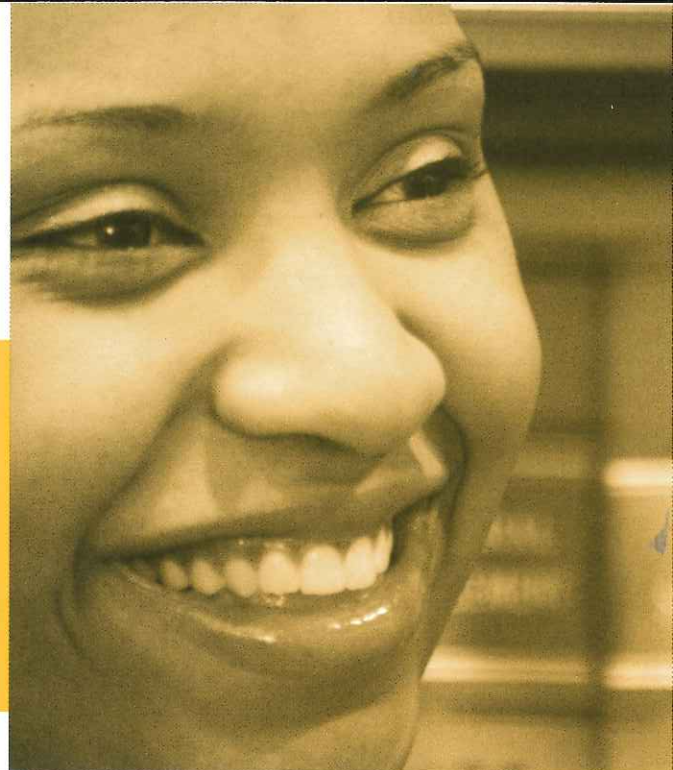

- + Provide access to sources of law.
- + Provide access to legal materials.
- + Assist with an overview of legal materials.
- + Assist with information on legal resource format, arrangement, structure or organization.
- + Provide referral information to available agencies that provide legal information.

**BUT WE
CANNOT**

- ▶ Give legal advice.
- ▶ Explain or interpret statutes, cases or regulations.
- ▶ Do the actual legal research.
- ▶ Give opinions on legal issues.
- ▶ Select specific laws, rules or forms.
- ▶ Assist with filling out forms.
- ▶ Choose language or terms for research
- ▶ Recommend a specific lawyer or law firm.
