AN ATTEMPTED HOLD-UP.

Frank Morgan, proprietor of the west side grocery store, was badly hurt about the head and shoulders Saturday night between 10 and 11 o'clock. As he was returning from town a man stepped out from behind the Christian church and struck him twice on the side of the head with an iron bolt, which caused him to fall. He arose, dazed, and the first thing he remembers he saw a revolver stuck in his face, and was told to hold hands up. He knocked the revolver out of the follow's hand. It discharged as it struck the pavement. The noise aroused the neighbors and soon John Haase and Rev. E. L. Hutchens were on the scene. The fellow evidently was frightened by the report of the revolver and ran east down Broad alley. Soon other neighbors were on the scene and Mr. Morgan was carried home and a physician called. It required eleven stitches to sew up the two wounds. He was prostrated for two days, but is improving now.

Greeson, the town marshal, and the sheriff from Martinsville worked on every clue and have had several persons questioned, and at last report had two young men in custody.

The Heine filling station north of town and the Hawkeye filling station at the corner of Indiana and High streets have both been molested within the last week, and officers are inclined to think the same parties are guilty.
